## 4.0 APPROVE MINUTES OF MARCH 9, 2015 MEETING

#### 6.0 REGULAR AGENDA

## 6.1 Systems Division Update – Status Reports

Uchida reported there is a CAD upgrade tomorrow, which is a relatively minor software patch update. The primary reason it is being done is to upgrade the Emergency Medical Dispatch software, which ties into CAD. Dispatch will be using cards during this timeframe and staying at NetCom versus the Alternate Site. This should alleviate any radio issues. There will be the challenge of dispatching off of cards, particularly for fire. Uchida anticipates being back on CAD by 1400 hours or sooner. For most of the fire agencies that have CAD, someone from Systems will need to make a trip out to upgrade the CAD at the station.

Uchida informed the group that she is still working on the RFI for the new CAD. She encouraged the fire agencies to begin thinking about their representation for the process and noted the importance of participation from a few fire user agencies. Uchida would like to convene such a group by the end of the summer. Kidd added that a consultant will be hired to facilitate the CAD selection process.

6.2 Coordination on Major Events Involving Fire and Law
Kidd reported, with Memorial Day weekend coming up, staffing levels will be increased
for the summer months. The Fourth of July holiday will follow which is the same
weekend as the Hollister motorcycle rally. This will mean additional staffing at NetCom
as well as the activation of the alternate site in Hollister.

#### 6.3 Proposed FY 15/16 Budget

Kidd distributed the proposed FY 15/16 budget. He noted the Board endorsed the preliminary budget after being presented to this group in March and this proposed budget is very similar to that one. The overall budget change is a 2.32% increase. He encouraged any questions regarding the proposed budget be directed to him. Kidd distributed a document showing the history of the budget changes dating back to FY 04/05.

## 7.0 OTHER ISSUES

7.1 Long Range Radio Infrastructure Management Planning Group Kidd reminded the group that he was previously directed to work with the County to develop a long range plan for radio infrastructure. He noted this is for any County-wide frequency. The group formed was originally County personnel but has expanded to include a Sheriff and Fire representative. The group has not met since the last Users meeting, so Kidd had no update.

## 7.2 Text to 9-1-1

Kidd reported UCSC and Scotts Valley have decided to move forward on accepting text to 9-1-1. At this point, the project involves Santa Cruz, San Benito, Monterey Counties and CHP. Uchida informed the group the State has not implemented a live text to 9-1-1project as of yet and needs to determine a funding model. Frawley inquired about NextGen coming to Santa Cruz County. Uchida responded that she believes the State has just closed their RFP for NextGen contractors and is working on the funding. Kidd noted NetCom has hired a part-time GIS employee in an attempt to stay ahead of the curve.

# 7.3 Monterey County Agencies

Kidd reported, since Salinas and other cities gave their two-year notice to Monterey Communications, it was decided to pursue a feasibility study that looks at a JPA model within Monterey County. The consultant hired to prepare a feasibility study for NetCom providing services, will now shift their focus to the other study.

## 9.0 ROUNDTABLE

- Barry reminded the group of EMS week celebration at the County Supervisors office on May 19 at 1000 hours.
- Kidd reported NetCom has an open recruitment for Dispatcher Assistant I. The agency hopes to hire three new employees. It is not bilingual only, but English/Spanish bilinguals are encouraged to apply.

## 10.0 ADJOURNMENT / NEXT MEETING
